**“DECLARING ZION EYES GENERAL MERCHANDISE AS SINGLE CALCULATED AND RESPONSIVE BIDDER AND FURTHER RECOMMENDING THE AWARD OF CONTRACT TO FOR THE PROCUREMENT OF OCD3/RDRRMC3 INSTITUTIONAL MATERIALS (TOKENS AND MEMENTOS) INTENDED FOR RDRRMC3 MEMBER AGENCIES AND OTHER STAKEHOLDERS”**

**WHEREAS**, the Bids and Awards Committee (BAC) received an approved Purchase Request from the Office of the Regional Director for the Procurement of OCD3/RDRRMC3 Institutional Materials (Tokens and Mementos) Intended for RDRRMC3 Member Agencies and Other Stakeholders with an approved budget of contract amounting to Php 70,000.00;

**WHEREAS**, the BAC, thru its Secretariat, posted the Request for Quotation (RFQ) in the Philippine Government Electronic Procurement System (PhilGEPS) and Office of Civil Defense (OCD) Website, in a conspicuous place at OCD Regional Office 3 (OCD3) Building, and subsequently sent the RFQ to various suppliers from 21 May 2021 to 27 May 2021;

**WHEREAS**, on 01 June 2021, the BAC convened and deliberated one (1) sealed quotation submitted and two (2) acknowledgements received;

**WHEREAS**, the BAC recommended to the Head of the Procuring Entity (HoPE) through a resolution, to declare Zioneyes General Merchandise with the quotation amounting to Fifty-Five Thousand Three Hundred Pesos (Php 55,300.00) as the Single Calculated Bidder and subject the said supplier to Post Qualification (PQ);

**WHEREAS**, on 02 June 2021, the PQ Team visited Zioneyes General Merchandise located in Barangay Silangan, Cubao, Quezon City to examine, verify, and validate the original copy of legal and financial documents submitted and conduct inspection at the supplier's office premises;

**WHEREAS**, the PQ Team submitted the PQ Report during a meeting held on 08 June 2021, and presented the Team's over-all assessment and evaluation;

**WHEREAS**, the BAC adopts the recommendation of the PQ Team to declare Zioneyes General Merchandise as the Single Calculated and Responsive Bidder, having passed the Post Qualification;

**NOW, THEREFORE**, We, the members of the BAC hereby recommend to the Head of Procuring Entity, for his consideration and approval, to declare **Zioneyes General Merchandise** as the Single Calculated and Responsive Bidder and award the contract for the **Procurement of OCD3/RDRRMC3 Institutional Materials (Tokens and Mementos) Intended for RDRRMC3 Member Agencies and Other Stakeholders** in the amount of **Fifty-Five Thousand Three Hundred Pesos (Php 55,300.00) only**.
