"RECOMMENDING THE AWARD OF CONTRACT TO THE MMJS PHARMACY & MEDICAL SUPPLIES THROUGH ALTERNATIVE PROCUREMENT UNDER SECTION 52.1b (SHOPPING) FOR THE PROCUREMENT 2ND AND 3RD QUARTER JANITORIAL SUPPLIES OF OCD XI"

WHEREAS, the Purchase Request of the Regional Office-XI for the Procurement 2nd and 3rd Quarter Janitorial Supplies of OCD XI was approved on July 9, 2021 with an Approved Budget for the Contract (ABC) of **Thirty Thousand Five Hundred Ninety Eight Pesos (Php 30,598.00)** which is included in the approved **OCDRO-XI DRRM FUND 2021**;

WHEREAS, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on July 21, 2021 and Philgeps Website on July 17, 2021;

WHEREAS, three (3) prospective bidders, namely; MMJS Pharmacy & Medical Supplies, Karvin Pharma Center & YourMed Marketing submitted their respective quotations and documents thereof prior to the opening of bids on July 22, 2021;

WHEREAS, opening of quotation was held on July 22, 2021 wherein three (3) proponents submitted their respective quotations as follows:




