**“RECOMMENDING THE AWARD OF CONTRACT TO THE VITALAB REDMARK CORPORATION THROUGH ALTERNATIVE PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE MEDICAL CHECKUP AND VACCINATION TO ALL OCD XI PERSONNEL”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Medical checkup and vaccination to all OCD XI Personnel was approved on July 6, 2021 with an Approved Budget for the Contract (ABC) of **One Hundred Nineteen Thousand Six Hundred Pesos (Php 119,600.00)** which is included in the approved **OCDRO-XI DRRM FUND 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on July 21, 2021 and Philgeps Website on July 17, 2021;

**WHEREAS**, three (3) prospective bidders, namely; Vitalab Redmark Corporation, Cabansag Women and Kids Medical Clinic & Hi-Precision Diagnostics submitted their respective quotations and documents thereof prior to the opening of bids on July 22, 2021;

**WHEREAS**, opening of quotation was held on July 22, 2021 wherein three (3) proponents submitted their respective quotations as follows:




