**WHEREAS**, the Approved Supplemental Project Procurement Management (PPMP) was submitted by the end-user to the Procurement Management Unit on the same day;

**WHEREAS**, the Approved Budget for the Contract (ABC) was **Three Million One Hundred Twenty Pesos (Php 3,120,000.00)** charged against the Quick Response Fund downloaded to the Regional Office;

**WHEREAS**, on 13 October 2021, the Emergency Purchase Certificate was approved by the Head of Procurement Entity (HoPE);

**WHEREAS**, the BAC Resolution adopting Alternative Method of Procurement Through Negotiated Procurement in Accordance with Section 53.2- Emergency Cases for the project was approved on 14 October 2021;

**WHEREAS**, the Bids and Awards Committee (BAC) through the BAC Secretariat issued Request for Quotation dated 14 October 2021;

**WHEREAS**, LJMRZ CATERING with address at Brgy. Bayubay, San Vicente, Ilocos Sur submitted quotation on the same date;







**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, hereby recommend to the HOPE the Award of Contract to LJMZRZ CATERING with its financial bid amounting to **Three Million One Hundred Nineteen Thousand Eight Hundred Forty Pesos (Php 3,119,840.00) Only** for the Provision of Catering Services for the Patients and Workers of Regional Supported COVID-19 Isolation Facilities in the Province of Ilocos Sur from October 16 to November 15, 2021.


