“RECOMMENDING C AND S AUTOMOTIVE SERVICE AND TRADING CENTER CO. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT FOR THE REPAIR AND REPLACEMENT OF PARTS OF ONE (1) UNIT OCD VEHICLE HYUNDAI WATER TRUCK AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD for the project **“For the repair and replacement of parts of One (1) unit OCD Vehicle Hyundai Water Truck”** whose funding source is from the GSD APB CY 2020 MOOE - GASS;

WHEREAS, the Approved Budget for the Contract is Two Hundred Sixty Eight Thousand Six Hundred Seventy Nine Pesos (**PhP 268,679.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPs Website, in the OCD Website, and in the OCD Bulletin Board on 27 November 2020;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 2 December 2020;

WHEREAS, the quotations / acknowledgements were opened on 4 December 2020 with the following results:

Gerardo Hernandez supported by Ms. Bebeth Gador of the BAC Secretariat. The PQ Team submitted a report to the BAC dated 10 December 2020, recommending the proponent as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare C and S Automotive Service and Trading Center Co. as the Single Calculated and Responsive Bidder;


