WHEREAS, the BAC received a Purchase Request from the PAO for the project “Printing Services for OCD 2021 Planner and Calendars” whose funding source is from the Realigned budget from PAO APB CY 2020;

WHEREAS, the Approved Budget for the Contract is Five Hundred Thirty Five Thousand Pesos (PhP 535,000.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 19 December 2020;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 23 December 2020;

WHEREAS, the quotations / acknowledgements were opened on 23 December 2020 with the following results:


FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:

- b. Issuance of a corresponding Notice of Award (NOA).




