“RECOMMENDING GNS CENTRAL TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF ADMISSION KITS FOR COVID-19 QUARANTINE/ISOLATION FACILITIES AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of admission kits was urgently requested by the Task Group Facilities to continue providing assistance to the COVID 19 patients at different COVID-19 Quarantine/Isolation Facilities;

WHEREAS, the BAC received a Purchase Request from the TGF for the project “Supply and Delivery of Admission Kits for COVID-19 Quarantine/Isolation Facilities” whose funding source is from the Bayanihan 2 Fund;

WHEREAS, the Approved Budget for the Contract is Fourteen Million Nine Hundred Fifty Five Thousand Pesos (**PhP 14,955,000.00**) only;

WHEREAS, the mode of procurement is Secion 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 12 April 2021;

WHEREAS, the quotations / acknowledgements were opened on 13 April 2021 with the following results:


