WHEREAS, the BAC received a Purchase Request from the PDPS for the project **“Hiring of One (1) Highly Technical Individual Consultant for the Policy Development and Planning Service (PDPS) for the Mid-Term Review of Strategic Plan 2020-2022”** whose funding source is from the PDPS APB FY 2021;
