“RECOMMENDING UC BIOSCIENCES INCORPORATED AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF COVID-19 RAPID ANTIGEN TEST KITS FOR OCD EMPLOYEES AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, a letter from Chairman of the National Task Force against COVID-19 was received, directing the Department of Health and the Office of Civil Defense to make necessary actions for the procurement of Antigen Rapid Test Kits for distribution in the Geographically-Isolated and Disadvantaged Areas;

WHEREAS, per DOH Memorandum 2020-0468 states that the use of rapid antigen tests is allowed for diagnostic testing of close contacts in communities and closed or semi-closed institutions with confirmed outbreaks and in remote settings where RT-PCR is not immediately available;

WHEREAS, the provision of Antigen test Kits was urgently requested by the Task Group Facilities for the use of OCD Employees;

WHEREAS, the BAC received a Purchase Request from the Task Group Facilities for the project **“Supply and Delivery of COVID-19 Rapid Antigen Test Kits for OCD Employees”** whose funding source is from the Continuing Appropriations – DRRM Fund;

WHEREAS, the Approved Budget for the Contract is Two Million Three Hundred Fifty Thousand Pesos (PhP 2,350,000.00) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 27 January 2021;

WHEREAS, the quotations / acknowledgements were opened on 28 January 2021 with the following results:
