**WHEREAS**, the BAC received a Purchase Request from the ICTD for the project **“Supply and Delivery of Mirrorless Camera to Support the Conduct of Disaster Response and Management Operations”** whose funding source is from the Quick Response Fund – Capital Outlay 2021 Stand-by Fund;

**WHEREAS**, the Approved Budget for the Contract is Three Hundred Ninety Three Thousand One Hundred Five and 81/100 Pesos (**PhP 393,105.81**) only;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 23 January 2021;

**WHEREAS**, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 27 January 2021;

**WHEREAS**, the quotations / acknowledgements were opened on 28 January 2021 with the following results:
