“RECOMMENDING IONE RESOURCES, INCORPORATED AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROCUREMENT OF PREPAID CREDIT FOR THE EIGHT (8) INMARSAT SATELLITE PHONES OF OCD-NDRRMC AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the ICTD for the project “Procurement of Prepaid Credit for the Eight (8) Inmarsat Satellite Phones of OCD-NDRRMC” whose funding source is from the OCD Quick Response Fund – Continuing Appropriations;

WHEREAS, the Approved Budget for the Contract is Two Hundred Forty Seven Thousand Eight Hundred Twenty Six Pesos (**PhP 247,826.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 23 January 2021;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 27 January 2021;

WHEREAS, the quotations / acknowledgements were opened on 28 January 2021 with the following results:
