**“RECOMMENDING BOSTON BUILDER’S CENTER AS THE SINGLE
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT
PROCUREMENT OF REPAIR AND MAINTENANCE MATERIALS FOR FACILITY
READINESS OF OCD’S FOUR (4) BUILDINGS AND THE ISSUANCE OF NOTICE
OF AWARD”**

WHEREAS, the BAC received a Purchase Request from the GSD for the project **“Procurement of Repair and Maintenance Materials for Facility Readiness of OCD’s Four (4) Buildings”** whose funding source is from the AFMS - GSD APB CY 2021 - MOOE GASS;

WHEREAS, the Approved Budget for the Contract is Forty Thousand Eight Hundred Eighty Eight and 33/100 Pesos (**PhP 40,888.33**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 29 January 2021;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 3 February 2021;

WHEREAS, the quotations / acknowledgements were opened on 4 February 2021 with the following results:
