**“RECOMMENDING HOUSING AFFAIRS OFFICE (TRANSIENT OFFICERS
QUARTERS) AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR
THE PROJECT PROVISION OF ACCOMMODATION FOR OCD OPCEN DUTY
PERSONNEL AND OCD SKELETAL WORKFORCE (15 FEBRUARY TO 31
MARCH 2021)”**

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of accommodation was urgently requested by the Human Resource Management and Development Division to continue providing assistance to the OCD duty Personnel scheduled for skeleton workforce during COVID 19 Pandemic;

WHEREAS, the BAC received a Purchase Request from the HRMDD for the project “Provision of Accommodation for OCD OpCen Duty Personnel and OCD Skeletal Workforce (15 February to 31 March 2021)” whose funding source is from the Continuing Appropriations for CY 2020;

WHEREAS, the Approved Budget for the Contract is Three Hundred Three Thousand Seven Hundred Fifty Pesos (**PhP 303,750.00**) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 11 February 2021;

WHEREAS, the quotations / acknowledgements were opened on 11 February 2021 with the following results:
