**Resolution No. 2021-02-C-013**

**“RECOMMENDING AFP TRANSIENT ENLISTED QUARTERS AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF ACCOMMODATION SERVICES FOR PCG PERSONNEL DEPLOYED IN OCD OPERATIONS CENTER FOR COVID-19 OPERATION (14 FEBRUARY 2021 TO 31 MAY 2021)”**

**WHEREAS**, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

**WHEREAS**, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

**WHEREAS**, the provision of accommodation was urgently requested by the Logistics Interoperability and Force Management Division to continue providing assistance to the PCG personnel deployed in OCD Operations Center;

**WHEREAS**, the BAC received a Purchase Request from the LIFMD for the project “**Provision of Accommodation services for PCG Personnel deployed in OCD Operations Center for COVID-19 Operation (14 February to 31 May 2021)**” whose funding source is from the Unprogrammed Appropriations (Bayanihan Act 2);

**WHEREAS**, the Approved Budget for the Contract is Six Hundred Forty Six Thousand Nine Hundred Ninety Four and 76/100 Pesos (**PhP 646,994.76**) only;

**WHEREAS**, the mode of procurement is Section 53.5 (Agency-to-Agency) and the deadline for the submission of eligibility and financial requirements of the project was on 11 February 2021;

**WHEREAS**, the quotations / acknowledgements were opened on 11 February 2021 with the following results:

**WHEREAS**, **AFP Transient Enlisted Quarters (AFPTEQ)**, after the evaluation of documents, was recommended by the BAC to be the Single Calculated and Responsive Bidder and for being the single, complying, reasonable and advantageous supplier/dealer, to the best interest of the government;

**NOW, THEREFORE**, the BAC, after due deliberation resolved to recommend to declare **AFP Transient Enlisted Quarters (AFPTEQ)** as the Single Calculated and Responsive Bidder;

**FURTHER**, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:

a. Approval of the recommendation to declare **AFP Transient Enlisted Quarters (AFPTEQ)** as the Single Calculated and Responsive Bidder; and

b. Issuance of a corresponding Notice of Award (NOA).
