“RECOMMENDING RMTD SELF OPERATED FUTURE LAUNDRY, INCORPORATED AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF LAUNDRY SERVICES (CLOTHING) FOR COVID-19 QUARANTINE FACILITY IN PHILIPPINE INTERNATIONAL CONVENTION CENTER (01 MARCH TO 31 MAY 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of laundry services was urgently requested by the Task Group Facilities to continue providing assistance to the staffs and patients in COVID-19 Quarantine Facility at Philippine International Convention Center;

WHEREAS, the BAC received a Purchase Request from the Task Group Facilities for the project “**Provision of Laundry Services (Clothing) for COVID-19 Quarantine Facility in Philippine International Convention Center (01 March to 31 May 2021)**” whose funding source is from the Bayanihan 2;

WHEREAS, the Approved Budget for the Contract is Ninety Seven Thousand Five Hundred Pesos (**PhP 97,500.00**) only;

WHEREAS, the mode of procurement is Emergency Cases and the deadline for the submission of eligibility and financial requirements of the project was on 23 February 2021;

WHEREAS, the quotations / acknowledgements were opened on 23 February 2021 with the following results:

WHEREAS, RMTD Self Operated Future Laundry, Incorporated was evaluated by the BAC to be the Single Calculated Bidder subject to Capacity Inspection;

WHEREAS, a Capacity Inspection was conducted on 24 February 2021 by the OCD Central Office Capacity Inspection Team composed of Ms. Vilma Gestiada, Ms. Janine Casimiro, and Mr. Noel Mapalo supported by Ms. Bebeth Gador of the BAC Secretariat. The Capacity Inspection Team submitted a report to the BAC dated 26 February 2021, recommending the proponent as capable to undertake the laundry services for COVID-19 Quarantine and Testing Facilities;

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **RMTD Self Operated Future Laundry, Incorporated** as the Single Calculated and Responsive Bidder;


FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:

- a. Approval of the recommendation to declare **RMTD Self Operated Future Laundry, Incorporated** as the Single Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).


