“RECOMMENDING C AND S AUTOMOTIVE SERVICE AND TRADING CENTER CO. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT REPAIR AND REPLACEMENT OF PARTS OF OCD VEHICLE TOYOTA HILUX SHY 431 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD for the project **“Repair and Replacement of parts of OCD Vehicle Toyota Hilux SHY 431”** whose funding source is from the GSD APB CY 2021 MOOE - GASS;

WHEREAS, the Approved Budget for the Contract is Fifty Two Thousand Nine Hundred Thirty Three and 33/100 Pesos (**PhP 52,933.33**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 20 February 2021;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 24 February 2021;

WHEREAS, the quotations / acknowledgements were opened on 26 February 2021 with the following results:
