**“RECOMMENDING ASP AIRSPEED PHILIPPINES, INCORPORATED AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF FREIGHT FORWARDING SERVICE – TEN- WHEELER TRUCKS FOR COVID 19 TGRML OPERATIONS 2021 AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

**WHEREAS**, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

**WHEREAS**, the provision Freight Forwarding Services was urgently requested by the Logistics Interoperability and Force Management Division for COVID-19 TGRML Operations 2021 for immediate transport of various supplies in response to the threat of COVID-19;

**WHEREAS**, the BAC received a Purchase Request from the LIFMD for the project “Provision of Freight Forwarding Service – Ten- Wheeler Trucks for COVID 19 TGRML Operations 2021” whose funding source is from the Bayanihan 2 Fund;

**WHEREAS**, the Approved Budget for the Contract is Seven Million Nine Hundred Fifty Two Thousand Eight Hundred Thirteen and 33/100 Pesos (**PhP 7,952,813.33**) only;

**WHEREAS**, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 30 March 2021;

**WHEREAS**, the quotations / acknowledgements were opened on 31 March 2021 with the following results:




