“RECOMMENDING GNS CENTRAL TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY AND DELIVERY OF COMMON-USE AND OTHER OFFICE SUPPLIES FOR COVID-19 QUARANTINE AND TESTING FACILITIES AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of office supplies was urgently requested by the Task Group Facilities to be used in different COVID-19 Quarantine and Testing Facilities;

WHEREAS, the BAC received a Purchase Request from the TGF for the project “Supply and Delivery of Common-Use and Other Office Supplies for COVID-19 Quarantine and Testing Facilities” whose funding source is from the Bayanihan 2 Fund;

WHEREAS, the Approved Budget for the Contract is One Million Two Hundred Eight Three Thousand Eight Hundred Fifty Pesos (PhP 1,283,850.00) only;

WHEREAS, the mode of procurement is Emergency Cases and the deadline for the submission of eligibility and financial requirements of the project was on 30 March 2021;

WHEREAS, the quotations / acknowledgements were opened on 31 March 2021 with the following results:

WHEREAS, GNS Central Trading, after the evaluation of submitted eligibility documents, was recommended by the BAC to be the Lowest Calculated and Responsive Bidder and for being the lowest, complying, reasonable and advantageous supplier/ dealer, to the best interest of the government;

NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare GNS Central Trading as the Lowest Calculated and Responsive Bidder with an offer of Nine Hundred Eighty Thousand Seven Hundred Seventy Five and 75/100 Pesos (PhP 980,775.75) only which is lower, pursuant to the provision of Section 34.4 of the 2016 Revised IRR of RA 9184;


FURTHER, We, the members of OCD-BAC hereby RECOMMEND to the HOPE the following:

- a. Approval of the recommendation to declare GNS Central Trading as the Lowest Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
