“RECOMMENDING MFA CAR RENTAL SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF SHUTTLE SERVICE FOR THE 2ND QUARTER OF CY 2021 FOR OCD SKELETAL WORKFORCE AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of transportation services was urgently requested by the Human Resource Management and Development Division to continue providing assistance to the OCD Personnel scheduled for skeleton workforce during COVID 19 Pandemic;

WHEREAS, the BAC received a Purchase Request from the HRMDD for the project “Provision of Shuttle Service for the 2nd Quarter of CY 2021 for OCD Skeletal Workforce” whose funding source is from the Continuing Appropriations CY 2020;

WHEREAS, the Approved Budget for the Contract is Five Million Thirty Two Thousand Five Hundred Pesos (PhP 5,032,500.00) only;

WHEREAS, the mode of procurement is Emergency Cases and the deadline for the submission of eligibility and financial requirements of the project was on 30 March 2021;

WHEREAS, the quotations / acknowledgements were opened on 31 March 2021 with the following results:


