**“RECOMMENDING CODO TRADING AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROCUREMENT OF CANOPY FOR FORD RANGER ISSUED TO COA – OCD FIELD OFFICE AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, the BAC received a Purchase Request from the GSD for the project **“Procurement of Canopy for Ford Ranger issued to COA – OCD Field Office”** whose funding source is from the GSD APB CY 2021;

**WHEREAS**, the Approved Budget for the Contract is Ninety Thousand Seven Hundred Fifty Eight and 50/100 Pesos (**PhP 90,758.50**) only;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPs Website, in the OCD Website, and in the OCD Bulletin Board on 9 April 2021;

**WHEREAS**, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 14 April 2021;

**WHEREAS**, the quotations / acknowledgements were opened on 15 April 2021 with the following results:

The PQ Team submitted a report to the BAC dated 22 April 2021, recommending the proponent as the Single Calculated and Responsive Bidder;

**NOW, THEREFORE**, the BAC, after due deliberation resolved to recommend to declare **CODO Trading** as the Single Calculated and Responsive Bidder;
