**“RECOMMENDING PENITON TRADING AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROCUREMENT OF STEEL RACKS FOR NDRRMC BUILDING AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, the BAC received a Purchase Request from the OS for the project “Procurement of Steel Racks for NDRRMC Building” whose funding source is from the OS DRRM Fund FY 2021;

**WHEREAS**, the Approved Budget for the Contract is Forty Seven Thousand Six Hundred Thirty Five Pesos (**PhP 47,635.00**) only;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 16 April 2021;

**WHEREAS**, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 21 April 2021;

**WHEREAS**, the quotations / acknowledgements were opened on 22 April 2021 with the following results:

**NOW, THEREFORE**, the BAC, after due deliberation resolved to recommend to declare Peniton Trading as the Single Calculated and Responsive Bidder;


**FURTHER**, We, the members of OCD-BAC (via Video-conferencing) hereby RECOMMEND to the HOPE the following:
