“RECOMMENDING BLUE STAR INTERIORS, INCORPORATED AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY, DELIVERY AND INSTALLATION OF COMBI BLINDS FOR THE ADMINISTRATION BUILDING AND WAREHOUSE BUILDING (VARIOUS OFFICES) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD for the project **“Supply, Delivery and Installation of Combi Blinds for the Administration Building and Warehouse Building (Various Offices)”** whose funding source is from the GSD APB CY 2021 – MOOE GASS;

WHEREAS, the Approved Budget for the Contract is Six Hundred Two Thousand Seven Hundred Fifteen and 60/100 Pesos (PhP 602,715.60) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPs Website, in the OCD Website, and in the OCD Bulletin Board on 29 April 2021;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 5 May 2021;

WHEREAS, the quotations / acknowledgements were opened on 6 May 2021 with the following results:


