“RECOMMENDING CHEFS ARCOR FOODS CORPORATION AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF CATERING SERVICES FOR COVID-19 QUARANTINE FACILITY IN BAGONG NAYONG PILIPINO (01 JUNE TO 30 SEPTEMBER 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled "An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act" was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of catering services was urgently requested by the Task Group Facilities to continue providing assistance to the staffs and patients designated in COVID-19 Quarantine Facility at Bagong Nayong Pilipino;

WHEREAS, the BAC received a Purchase Request from the TGF for the project "Provision of Catering Services for COVID-19 Quarantine Facility in Bagong Nayong Pilipino (01 June to 30 September 2021)" whose funding source is from the SARO-BMB-D-21-0000256;

WHEREAS, the Approved Budget for the Contract is Nineteen Million Sixty One Thousand Two Hundred Eighty Pesos (PhP 19,061,280.00) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 18 May 2021;

WHEREAS, the quotations / acknowledgements were opened on 18 May 2021 with the following results:


