“RECOMMENDING JOINT VENTURE OF SERVO-TREAT PHILIPPINES, INCORPORATED AND METRO CLARK WASTE MANAGEMENT CORPORATION AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF WASTE MANAGEMENT SERVICES FOR COVID-19 QUARANTINE FACILITY IN BAGONG NAYONG PILIPINO (01 JUNE TO 30 SEPTEMBER 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of waste management services was urgently requested by the Task Group Facilities to continue providing assistance to the staffs and patients in COVID-19 Quarantine Facility at Bagong Nayong Pilipino;

WHEREAS, the BAC received a Purchase Request from the Task Group Facilities for the project “Provision of Waste Management Services for COVID-19 Quarantine Facility in Bagong Nayong Pilipino (01 June to 30 September 2021)” whose funding source is from the SARO-BMB-D-21-0000256;

WHEREAS, the Approved Budget for the Contract is Eight Hundred Forty Five Thousand Four Hundred Sixty Pesos (PhP 845,460.00) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 27 May 2021;

WHEREAS, the quotations / acknowledgements were opened on 27 May 2021 with the following results:

WHEREAS, Cleanway Environmental Management Solutions Incorporated and Joint Venture of Servo-Treat Philippines, Incorporated and Metro Clark Waste Management Corporation, tendered the same amount of **Five Hundred Eighty Nine Thousand Two Hundred Sixty Pesos (PHP 589,260.00)**, which were evaluated by the BAC to be the Lowest Calculated Bidder;

WHEREAS, to determine to whom the project will be awarded, the tie was broken through "toss coin" as agreed upon by the two (2) proponents which is in consonance with *GPPB Circular 06-2005* and won by **Joint Venture of Servo-Treat Philippines, Incorporated and Metro Clark Waste Management Corporation**, subject to Capacity Inspection;

WHEREAS, a Capacity Inspection was conducted on 31 May 2021 by the OCD Central Office Capacity Inspection Team composed of Ms. Vilma Gestiada, Mr. Paolo Jonas Alan, Ms. Janine Casimiro, and Mr. Noel Mapalo supported by Mr. Vicente Barrito III of the BAC Secretariat. The Capacity Inspection Team submitted a report to the BAC dated 31 May 2021, recommending the proponent as capable to undertake the waste management services for COVID-19 Quarantine Facilities;

NOW, THEREFORE, the BAC (via Video-teleconferencing), after due deliberation resolved to recommend to declare **Joint Venture of Servo-Treat Philippines, Incorporated and Metro Clark Waste Management Corporation** as the Lowest Calculated and Responsive Bidder;


FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:


- a. Approval of the recommendation to declare **Joint Venture of Servo-Treat Philippines, Incorporated and Metro Clark Waste Management Corporation** as the Lowest Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
