“RECOMMENDING ZIONEYES GENEREAL MERCHANDISE AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROCUREMENT OF MEMENTOS AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the OS 24/7 for the project “Procurement of Mementos” whose funding source is from the DRRM-Continuing Appropriation FY 2020;

WHEREAS, the Approved Budget for the Contract is Two Hundred Eighty Thousand Nine Hundred Thirty Two Pesos (**PhP 280,932.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPs Website, in the OCD Website, and in the OCD Bulletin Board on 8 May 2021;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 12 May 2021;




