Resolution No. 2021-05-C-036

“RECOMMENDING DEARJOHN SERVICES, INCORPORATED AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF JANITORIAL SERVICES FOR THE COVID-19 QUARANTINE FACILITY AT RIZAL MEMORIAL COLISEUM (1 JUNE TO 30 SEPTEMBER 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of janitorial services was urgently requested by the Task Group Facilities to continue providing assistance to the staffs and patients in COVID-19 Quarantine Facility at Rizal Memorial Coliseum;

WHEREAS, the BAC received a Purchase Request from the Task Group Facilities for the project “**Provision of Janitorial Services for the COVID-19 Quarantine Facility at Rizal Memorial Coliseum (1 June to 30 September 2021)**” whose funding source is from the SARO-BMB-D-21-0000256;

WHEREAS, the Approved Budget for the Contract is One Million Two Hundred Fifty Two Thousand Five Hundred Ten and 58/100 Pesos (**PhP 1,252,510.58**) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 20 May 2021;

WHEREAS, the quotations / acknowledgements were opened on 20 May 2021 with the following results:


FURTHER, We, the members of OCD-BAC hereby RECOMMEND to the HOPE the following:

RESOLVED, this 25th day of May 2021 at the Office of Civil Defense, Camp General Emilio Aguinaldo, Quezon City, Philippines.


