“RECOMMENDING BLUE AND GOLD CATERING SERVICES AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF CATERING SERVICES FOR COVID-19 TESTING FACILITY IN PHILIPPINE ARENA (01 JUNE TO 30 SEPTEMBER 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of catering services was urgently requested by the Task Group Facilities to continue providing assistance to the staffs designated in COVID-19 Testing Facility at Philippine Arena;

WHEREAS, the BAC received a Purchase Request from the TGF for the project “Provision of Catering Services for COVID-19 Testing Facility in Philippine Arena (01 June to 30 September 2021)” whose funding source is from the SARO-BMB-D-21-0000256;

WHEREAS, the Approved Budget for the Contract is Twenty Million Two Hundred Three Thousand Two Hundred Pesos (PhP 20,203,200.00) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 18 May 2021;

WHEREAS, the quotations / acknowledgements were opened on 18 May 2021 with the following results:

WHEREAS, Cordings Bulaluhan and Catering Services was evaluated by the BAC to be the Lowest Calculated Bidder subject to Capacity Inspection;

WHEREAS, a Capacity Inspection to Cordings Bulaluhan and Catering Services was conducted on 19 May 2021 by the OCD Central Office Capacity Inspection Team composed of Ms. Vilma Gestada, Mr. Paolo Jonas Alan, and Mr. Noel Mapalo supported by Mr. Vicente Barrito III of the BAC Secretariat, The Capacity Inspection Team submitted a report to the BAC dated 20 May 2021, recommending the proponent as capable to undertake the said project;

WHEREAS, the BAC recommended the issuance of Notice of Award in favor of Cordings Bulaluhan and Catering Services;

WHEREAS, on 25 May 2021, Cordings Bulaluhan and Catering Services sent an email stating that they can no longer accept the said project and recommended to conduct a Capacity Inspection to **Blue and Gold Catering Services** for being the next qualified bidder;

WHEREAS, on 26 May 2021, the BAC accepted the withdrawal email of Cordings Bulaluhan and Catering Services;

WHEREAS, a Capacity Inspection to **Blue and Gold Catering Services** was conducted on 26 May 2021 by the OCD Central Office Capacity Inspection Team composed of Mr. Elvis, Mr. Paolo Jonas Alan, and Mr. Noel Mapalo supported by Ms. Fay Ashley Mamangon of the BAC Secretariat, The Capacity Inspection Team submitted a report to the BAC dated 27 May 2021, recommending the proponent as capable to undertake the said project;

NOW, THEREFORE, the BAC (via Video-teleconferencing), after due deliberation resolved to recommend to declare **Blue and Gold Catering Services** as the Single Calculated and Responsive Bidder;

FURTHER, We, the members of OCD-BAC hereby RECOMMEND to the HOPE the following:

- a. Approval of the recommendation to declare **Blue and Gold Catering Services** as the Single Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
