WHEREAS, the BAC received a Purchase Request from the HRMDD for the project “Provision of Mobile Pedestal for HRMDD” whose funding source is from the MRE CY 2021;

WHEREAS, the Approved Budget for the Contract is Ninety Five Thousand Four Hundred Fifty Pesos (PhP 95,450.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 2 July 2021;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 7 July 2021;



RESOLVED, this 15th day of July 2021 at the Office of Civil Defense, Camp General Emilio Aguinaldo, Quezon City, Philippines.




