WHEREAS, the BAC received a Purchase Request from the PDPS for the project “Hiring of Highly Technical Researchers/Writers (Team/Firm) for the Development of the OCD Accomplishment Reports 2016 to 2022” whose funding source is from the PDPS-PPDMD APB FY-2021 (Modified);

WHEREAS, the Approved Budget for the Contract is Three Hundred Fifty Thousand Pesos (PhP 350,000.00) only;

WHEREAS; the mode of procurement is Section 53.7 (Highly Technical Consultant) and the deadline for the submission of eligibility and financial requirements of the project was on 21 July 2021;




- a. Approval of the recommendation to declare **GRA: Global Resilience Academy Co.** as the Single Calculated and Responsive Bidder; and
