**“RECOMMENDING BONIFACIO HOTEL VENTURES, INCORPORATED (SEDA BGC HOTEL) AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION HOTEL ACCOMMODATION AND MEALS FOR PERSONNEL DEPLOYED AT COVID-19 TESTING FACILITY IN NINOY AQUINO STADIUM (01-30 NOVEMBER 2021) AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, on 16 September 2020, the President signed Proclamation No. 1021, extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021;

**WHEREAS**, on 10 September 2021, the President signed Proclamation No. 1218 further extending the period of State of Calamity due to COVID-19 until 12 September 2022;

**WHEREAS**, during the State of Calamity the Office of Civil Defense through Task Group Facilities (TGF) continues to provide logistical support to various COVID-19 quarantine and testing facilities and response operations;

**WHEREAS**, the BAC received a Purchase Request from the TGF for the project **“Provision Hotel Accommodation and Meals for Personnel Deployed at COVID-19 Testing Facility in Ninoy Aquino Stadium (01-30 November 2021)”**, with funding source from the OCD Quick Response Fund CY 2021;

**WHEREAS**, the Approved Budget for the Contract is Ten Million Nine Hundred Sixty Eight Thousand Pesos (**PhP 10,968,000.00**) only;

**WHEREAS**, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 26 October 2021;

**WHEREAS**, the quotations / acknowledgements were opened on 26 October 2021 with the following results:


**FURTHER,** We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:


