**“RECOMMENDING EDCT FOOD SERVICES
AS THE SERVICE PROVIDER FOR THE SUPPLY AND DELIVERY OF PACKED
MEALS AT CARMONA MEGA ISOLATION FACILITY, BRGY. LANTIC,
CARMONA, CAVITE”**

WHEREAS, Republic Act 11494 was approved on 11 September 2020 with subject “Bayanihan to Recover As One Act” to provide COVID-19 response and recovery interventions and to provide mechanisms to accelerate the recovery and bolster the resiliency of the Philippine Economy, providing funds therefore and for other purposes;

WHEREAS, Proclamation No 1021 was issued 16 September 2020 extending the period of State of Calamity throughout the Philippines due to Corona Virus Disease 2019 since the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, the BAC received a Purchase Request from OCD CALABARZON – DRRM Division Chief for the **SUPPLY AND DELIVERY OF PACKED MEALS AT CARMONA MEGA ISOLATION FACILITY, BRGY. LANTIC, CARMONA, CAVITE** with Approved Budget for the Contract in the amount of **FOUR MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND PESOS (₱4,968,000.00) ONLY**, which was duly approved by HOPE on **07 February 2021** with funding source from Unprogrammed Appropriations (Bayanihan Act 2) and was downloaded to OCD CALABARZON Regular Fund;

WHEREAS, the mode of procurement adapted is Negotiated Procurement under Emergency Case per Republic Act No. 11494 or the “Bayanihan to Recover as One Act” and GPPB Resolution 18-2020;

WHEREAS, the request for quotation for the said procurement project was posted thrice at the OCD Website on the following dates: 18 January 2021, 01 February 2021 and 07 February 2021;

WHEREAS, in all three postings, no supplier has signified interest and submitted quotation/proposal for the supply and delivery of packed meals for Carmona Mega Isolation Facility;

WHEREAS, the BAC convened on 11 February 2021 and agreed to resort into negotiation with a legally, financially and technically qualified supplier due to the emergency nature of the services for **CARMONA MEGA ISOLATION FACILITY**;

WHEREAS, EDCT Food Services, the current supplier of meals offered to bid in the amount of THREE MILLION NINE HUNDRED THIRTY-THREE THOUSAND PESOS (Php 3,933,000.00) ONLY;

WHEREAS, EDCT Food Services also presented their PhilGEPS Platinum Membership and other documentary requirements;

WHEREAS, after deliberation by the members, the BAC concurred to award the contract to EDCT Food Services;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the OCD Calabarzon BAC after due deliberation resolved to recommend to declare EDCT Food Services as the Single Calculated and Responsive Offeror;


FURTHER, WE , the Members of the OCD Calabarzon BAC, RECOMMEND to the Head of the Procuring Entity (HoPE) the following;

- a. To declare **EDCT FOOD SERVICES** as the **SERVICE PROVIDER** for the **CARMONA MEGA ISOLATION FACILITY, BRGY. LANTIC, CARMONA, CAVITE;**
- b. The issuance of **NOTICE OF AWARD (NOA)** in favor of **EDCT FOOD SERVICES** in the amount of **THREE MILLION NINE HUNDRED THIRTY THREE THOUSAND PESOS (Php 3,933,000.00) ONLY;**


