“RECOMMENDING TO DECLARE EDCT FOOD SERVICES AS THE SERVICE PROVIDER OF MEALS AT CARMONA MEGA ISOLATION FACILITY”

WHEREAS, Republic Act 11494 was approved on 11 September 2020 with subject “Bayanihan to Recover As One Act” to provide COVID-19 response and recovery interventions and to provide mechanisms to accelerate the recovery and bolster the resiliency of the Philippine Economy, providing funds therefore and for other purposes;

WHEREAS, Proclamation No 1021 was issued 16 September 2020 extending the period of State of Calamity throughout the Philippines due to Corona Virus Disease 2019 since the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 was issued 29 December 2020 extending the availability of appropriations under Republic Act No. 11494 otherwise known as “Bayanihan to Recover As One Act”;

WHEREAS, the BAC received a Purchase Request from OCD CALABARZON – DRRM Division Chief for the **PROVISION OF MEALS FOR CARMONA MEGA ISOLATION FACILITY** with the Approved Budget for the Contract (ABC) of **SIX HUNDRED EIGHTY FOUR THOUSAND PESOS (P684,000.00) ONLY** which was duly approved by HOPE on **3 May 2021** with funding source from Unprogrammed Appropriations (Bayanihan Act 2) and was downloaded to OCD CALABARZON Regular Fund;

WHEREAS, the BAC Chairperson recommended to convene the Bids And Awards Committee on **13 May 2021** to discuss the mode of procurement to be use for the **PROVISION OF MEALS FOR CARMONA MEGA ISOLATION FACILITY** which is expected deliver on **01 June 2021**;

WHEREAS, after thorough deliberation, the BAC agreed to recommend the adoption of **Negotiated Procurement under Emergency Case per RA 11494** as the mode of procurement with a reference under **GPPB Resolution No. 18-2020**;

WHEREAS, the request for quotation, terms of references and invitation to bid for the said procurement project was sent to different service provider by the procurement unit via official email address of Office of Civil Defense CALABARZON starting **14 May 2021, 09:00PM** and closed on **15 May 2021, 01:00PM**;

WHEREAS, at 01:00PM of 15 May 2021, there were three (3) service providers who acknowledge the emailed request for quotation namely: 1) Lakai Cocina Food Services, 2) EDCT Food Services and 3) Alon's Catering Services;

WHEREAS, out of these three (3), only two (2) submitted their proposal and quotation namely: 1) Lakai Cocina Food Services, 2) EDCT Food Services and considered Alon's Catering Services as disqualified;

WHEREAS, the BAC convened on 15 May 2021, 06:30PM, to open the bids of the qualified offeror;

WHEREAS, Lakai Cocina Food Services and EDCT Food Services both complied with the set documentary requirements based on their submission but having a bid amount of **Php 672,600.00**, EDCT Food Services was declared by the BAC as **Lowest Calculated offeror** against **Php 684,000.00** of Lakai Cocina Food Services and subject for Post Qualification on 16 May 2021, 01:00PM;

WHEREAS, the BIDS and Awards Committee of OCD IV-A conducted post qualification to EDCT FOOD SERVICES via video teleconferencing to verify the authenticity of the submitted eligibility documents on 16 May 2021, Sunday at 01:00PM where the proponent passed the legal and technical requirements of the BAC based on the terms of references provided and considered as the most advantageous to the government;

WHEREAS, after deliberation by the members of the BAC on 16 May 2021, 07:30PM, they concurred to award the contract to EDCT Food Services;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the **OCD CALABARZON BAC** after due deliberation resolved to recommend to declare **EDCT Food Services** as the **Lowest Calculated and Responsive Offeror**;



- b. The issuance of **NOTICE OF AWARD (NOA)** in favor of **EDCT FOOD SERVICES** in the amount of **SIX HUNDRED SEVENTY TWO THOUSAND SIX HUNDRED PESOS (Php 672,600.00) ONLY**;






