“RECOMMENDING THE AWARD OF CONTRACT TO FERDINAND G. CABRERA (FGC CONSTRUCTION) UNDER SECTION 53.7 HIGHLY TECHNICAL CONSULTANT FOR THE PROJECT HIRING OF AN INTERIOR DESIGN CONSULTANT FOR THE GOVERNMENT COMMAND AND CONTROL CENTER (GCCC) IN BRGY. BANCASI, BUTUAN CITY”

WHEREAS, the Purchase Request of OCD Caraga for the **Hiring of an Interior Design Consultant for the Government Command and Control Center (GCCC) in Brgy. Bancasi, Butuan City** was approved with an Approved Budget Contract (ABC) of **One Hundred Fifty Thousand Pesos Only (P 150,000.00)** which is included in the approved MOOE Fund 2021.

WHEREAS, the Office of Civil Defense Caraga posted Request for Quotation (RFQ) invitation at OCD website for probable providers in the area.

WHEREAS, Ferdinand G. Cabrera (FGC Construction) submitted their quotation and documents thereof prior to the opening of bids on August 03, 2021.

WHEREAS, WHEREAS, all bid documents were opened on August 03, 2021 with the following results:

WHEREAS, the offer made by **Ferdinand G. Cabrera (FGC Construction)** was determined by the BAC to be the Single Calculated Bid for the said project.

WHEREAS, Ferdinand G. Cabrera (FGC Construction) was determined and evaluated by the BAC as the most advantageous and economical to the government, thereby said proponent as the **Single Calculated Bidder**;


WHEREAS, Section 12 of R.A. 9184 mandates that the OCD Caraga BAC shall recommend the award of the contract to the Head of the Procuring Entity or her duty authorized representative.

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of BAC, hereby RECOMMEND to the Head of Procuring Entity (HoPE), the following:

- a. To declare **Ferdinand G. Cabrera (FGC Construction)** as the **Single Calculated Bidder**; and
- b. The issuance of a Notice of Award (NOA) in favor of **Ferdinand G. Cabrera (FGC Construction)** in the amount of **Twenty-Five Thousand Pesos (PhP 25,000.00) per month for 6 months (P 150,000.00 in total) inclusive of 12% VAT per month.**
