“RECOMMENDING MAC KUSINA DE KAFE AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF MEALS FOR THE SUPPORT FOR HAULERS RE OCD COVID-19 RESPONSE FROM 01 NOVEMBER – 31 DECEMBER 2020 AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Republic Act 11494 was approved on 11 September 2020 with subject “Bayanihan to Recover As One Act” to provide COVID-19 Response and recovery interventions and to provide mechanisms to accelerate the recovery and bolster the resiliency of the Philippine Economy, Providing Funds therefor, and for other purposes;

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 since the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, the provision of packed meals was urgently requested by the LIFMD to continue providing assistance for the haulers, support personnel and repackers to ensure the safety of each frontliners;

WHEREAS, the BAC received a Purchase Request from the LIFMD for the project “Provision of Meals for the support for Haulers re OCD COVID-19 Response from 01 November – 31 December 2020” whose funding source is from the OCD QRF 2020;

WHEREAS, the Approved Budget for the Contract is Six Million One Hundred Thousand Pesos (PhP 6,100,000.00) only;

WHEREAS, the mode of procurement to be Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 30 October 2020;

WHEREAS, the quotations / acknowledgements were opened on 30 September 2020 with the following results:
