**“RECOMMENDING GREAT EASTERN HOTEL, INCORPORATED AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF HOTEL/VENUE/ACCOMMODATION FOR THE CONDUCT OF 4-DAY CONTINGENCY PLANNING TRAINING COURSE FOR OCD PERSONNEL (BLENDED) (17-21 MAY 2021) AND THE ISSUANCE OF NOTICE OF AWARD”**

WHEREAS, the BAC received a Purchase Request from the CBTS for the project “Provision of Hotel/Venue/Accommodation for the Conduct of 4-Day Contingency Planning Training Course for OCD Personnel (Blended) (17-21 May 2021)” whose funding source is from the CBTS APB FY 2021;

WHEREAS, the Approved Budget for the Contract is One Hundred Forty Thousand Eight Hundred Pesos (PhP 140,800.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 24 March 2021;

WHEREAS, the mode of procurement is Section 53.10 (Lease of Real Property and Venue) and the deadline for the submission of eligibility and financial requirements of the project was on 30 March 2021;

WHEREAS, the quotations / acknowledgements were opened on 31 March 2021 with the following results:

The PQ Team submitted a report to the BAC dated 8 April 2021, recommending the proponent as the Lowest Calculated and Responsive Bidder;


