WHEREAS, the Purchase Request (PR) No. 2021-12-0147 of the Operations Section under the Disaster Risk Reduction and Management Division of OCD RO-I for the Provision of COVID-19 Rapid Antigen Test Kits for OCD Region 1 was approved and submitted on 01 December 2021;

WHEREAS, the Approved Budget for the Contract (ABC) is **Two Million Eight Hundred Eighty Thousand Pesos (Php 2, 880,000.00) only**;

WHEREAS, on the same day, a Supplemental Project Procurement Management Plan (PPMP) and Emergency Purchase Certificate were submitted by the implementing unit, and approved by OCD RO-I Regional Director Eugene G. Cabrera;

WHEREAS, the BAC Resolution adopting Alternative Method of Procurement Through Negotiated Procurement in Accordance with Section 53.2-Emergency Cases for the project was approved on 02 December 2021;

WHEREAS, the BAC Secretariat issued Request for Quotation on 03 December 2021;

WHEREAS, the implementing unit sent the Request for Quotation to prospected eligible supplier;

WHEREAS, on the same day, SURGICO PHILS., INC. responded and submitted its quotation;

WHEREAS, upon receipt of the quotation, the implementing unit evaluated the bid and determined that the supplier passed the technical specifications, financial requirement, and submitted the eligibility documents needed for the project:
