“RECOMMENDING PENITON TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT SUPPLY, DELIVERY AND INSTALLATION OF FOUR LAYER ADJUSTABLE STEEL RACKS AND THREE LAYER FILING CABINETS FOR ISO REQUIREMENTS AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the GSD for the project **“Supply, Delivery and Installation of Four Layer Adjustable Steel Racks and Three Layer Filing Cabinets for ISO Requirements”** whose funding source is from the **GSD APB CY 2020-MOOE GASS**;

WHEREAS, the Approved Budget for the Contract is Seven Hundred Thirty Nine Thousand Two Hundred Twenty One Pesos (**PhP 739,221.00**) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 11 December 2020;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 16 December 2020;

WHEREAS, the quotations / acknowledgements were opened on 17 December 2020 with the following results:
