“RECOMMENDING GOLDEN PHOENIX HOTEL MANILA AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF HOTEL ACCOMMODATION AND MEALS FOR PCG PERSONNEL DEPLOYED FOR COVID-19 OPERATIONS UNDER TGA OSS TASK UNIT BALIK-PROBINSYA (01 JUNE TO 30 SEPTEMBER 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 until 12 September 2021. Considering the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the provision of hotel accommodation and meals was urgently requested by the Task Group Facilities to continue providing assistance to the Philippine Coast Guard personnel deployed for COVID-19 Operations under TGA OSS Task Unit Balik-Probinsya;

WHEREAS, the BAC received a Purchase Request from the Task Group Facilities for the project “**Provision of Hotel Accommodation and Meals for PCG Personnel Deployed for COVID-19 Operations under TGA OSS Task Unit Balik-Probinsya (01 June to 30 September 2021)**” whose funding source is from the SARO-BMB-D-21-0000256;

WHEREAS, the Approved Budget for the Contract is Twenty One Million Nine Hundred Sixty Thousand Pesos (**PhP 21,960,000.00**) only;

WHEREAS, the mode of procurement is Section 53.2 (Emergency Cases) and the deadline for the submission of eligibility and financial requirements of the project was on 25 May 2021;

WHEREAS, the quotations / acknowledgements were opened on 25 May 2021 with the following results:

WHEREAS, a Capacity Inspection was conducted on 26 May 2021 by the OCD Central Office Capacity Inspection Team composed of Ms. Vilma Gestuada, Ms. Janine Casimiro, and Mr. Noel Mapalo supported by Ms. Bebeth Gador of the BAC Secretariat. The Capacity Inspection Team submitted a report to the BAC dated 27 May 2021, recommending the proponent as capable to undertake the said project;

NOW, THEREFORE, the BAC (via Video-teleconferencing), after due deliberation resolved to recommend to declare **Golden Phoenix Hotel Manila** as the Lowest Calculated and Responsive Bidder;

FURTHER, We, the members of OCD-BAC hereby RECOMMEND to the HOPE the following:

- a. Approval of the recommendation to declare **Golden Phoenix Hotel Manila** as the Lowest Calculated and Responsive Bidder; and
- b. Issuance of a corresponding Notice of Award (NOA).
