WHEREAS, the BAC received a Purchase Request from the CBTS for the project “Provision of Vehicle Rental for Various CBTS Activities” whose funding source is from the CBTS APB CY 2021;

WHEREAS, the Approved Budget for the Contract is Sixty Thousand Pesos (PhP 60,000.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 7 January 2021;
