FRANCIS SQUARE DEVELOPMENT CORPORATION (BSA TWIN TOWERS) AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF HOTEL/ VENUE/ ACCOMMODATION FOR THE CONDUCT 2-DAY COMMUNITY-BASED DRRM TRAINING FOR OCD PERSONNEL (BLENDED) (10-12 MARCH 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the CBTS for the project “Provision of hotel/ venue/ accommodation for the conduct 2-Day Community-Based DRRM Training for OCD Personnel (Blended) (10-12 March 2021)” whose funding source is from the CBTS APB CY 2021;

WHEREAS, the Approved Budget for the Contract is Seventy Thousand Four Hundred Pesos (PhP 70,400.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 14 January 2021;

WHEREAS, the mode of procurement is Section 53.10 (Lease of Real Property and Venue) and the deadline for the submission of eligibility and financial requirements of the project was on 20 January 2021;

b. Issuance of a corresponding Notice of Award (NOA).


