“RECOMMENDING THE AWARD OF CONTRACT TO COSTSAVER’S SUPERMARKET, INC. FOR THE PROVISION OF JANITORIAL SUPPLIES FOR THE COVID-19 ISOLATION FACILITIES IN REGION 1”

WHEREAS, on 11 September 2020, President Rodrigo Roa Duterte signed Republic Act (RA) No. 11494 or the “Bayanihan to Recover as One Act (Bayanihan 2)” in view of the continuous health emergency operation against the spread of the Coronavirus Disease – 2019 (COVID-19);

WHEREAS, on 29 December 2020, the OCD RO-I submitted a request for continuation of support to the COVID-19 Isolation Facilities in Region 1 under the Bayanihan Act 2 to the OCD Central Office (CO);

WHEREAS, in view of the effectivity of RA 11519, on 08 January 2021, the OCD CO issued OCD Memorandum No. 18, s. 2021 reiterating validity extension of the Republic Act (RA) No. 11494 or the “Bayanihan to Recover as One Act (Bayanihan 2)” likewise extending the validity of the Bayanihan 2 Funds until 30 June 2021;

WHEREAS, on 13 January 2021, the OCD CO approved the request for the continuous and additional operational and maintenance requirements under the Bayanihan Act 2;

WHEREAS, on 24 March 2021, the Operations Section under the Disaster Risk Reduction and Management (DRRM) Division submitted the approved Purchase Request (PR) No. 2021-03-0058, the Supplemental Project Procurement Management Plan (PPMP) and Emergency Purchase Certificate (EPC) No. 2021-03-0004 for the said project;

WHEREAS, the initial bid opportunity was cancelled for mandatory review of the technical specifications;

WHEREAS, on 27 April 2021, the Operations Section submitted the approved PR No. 2021-04-0074 with revised specifications for the **Provision of Janitorial Supplies for the COVID-19 Isolation Facilities in Region 1 (Annex A)**;

WHEREAS, the Approved Budget for the Contract (ABC) was **One Million Three Hundred Thousand Pesos (Php 1,300,000.00)** charged against the RF - Bayanihan Act 2;

WHEREAS, on the same day of request, 27 April 2021, OCD RO-I Regional Director Eugene G. Cabrera, as Head of the Procuring Entity (HoPE) approved the Supplemental PPMP (**Annex B**) and the EPC No. 2021-04-0011 (**Annex C**) recommending the adoption of **Alternative Method of Procurement** in accordance with **Negotiated Mode of Procurement - Section 53.2 for Emergency Cases** of the Revised Implementing Rules and Regulations (IRR) of RA 9184 for the implementation of the said project;

WHEREAS, the Government Procurement Policy Board (GPPB) Resolution No. 03-2020 dated 09 March 2020 provides that **Alternative Method of Procurement** in accordance with **Negotiated Mode of Procurement under Section 53.2 for Emergency Cases** of the Revised IRR of RA 9184 can be undertaken for *"instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation"*;


WHEREAS, GPPB Resolution No. 03-2020 dated 09 March 2020 authorized the End-User aside from the BAC to recommend to the HoPE or his duly authorized representative the immediate award of contract to the supplier known to have the legal, technical and financial capability;

WHEREAS, 29 March 2021, the OCD RO-I issued the Request for Quotation (RFQ) No. 2021-04-0059 (**Annex D**);

WHEREAS, the implementing section, with the extended validity of Bayanihan 2, initiated the identification and negotiation with the prospective supplier namely, **COSTSAVER'S SUPERMARKET, INC.**, which complied with the technical and financial specifications of the project;

WHEREAS, the Operations Section further recommended **COSTSAVER'S SUPERMARKET, INC.** as the legally, technically and financially capable supplier for procurement of the said project;

NOW, THEREFORE, WE, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, indorse the recommendation of the implementing section, hereby **RECOMMEND** to the HoPE, the immediate award of contract to **COSTSAVER'S SUPERMARKET, INC.** for the **Provision of**


