**Resolution No. OCD-RO-I-05-0077, s. 2021**

**“RECOMMENDING THE AWARD OF CONTRACT TO SURGICO PHILS., INC.  
FOR THE SUPPLY AND DELIVERY OF COVID-19 REVERSE TRANSCRIPTION –  
POLYMERASE CHAIN REACTION (RT-PCR) TEST KIT SUPPLIES FOR THE  
PROVINCE OF ILOCOS NORTE”**

**WHEREAS**, on 11 September 2020, President Rodrigo Roa Duterte signed Republic Act (RA) No. 11494 or the “Bayanihan to Recover as One Act (Bayanihan 2)” in view of the continuous health emergency operation against the spread of the Coronavirus Disease – 2019 (COVID-19);

**WHEREAS**, on 23 December 2020, the OCD RO-I sent a letter to OCD Central Office (CO) endorsing the request of the Province of Ilocos Norte for Bayanihan Act 2 funds amounting to Php 72,476,050.00;

**WHEREAS**, in view of the effectivity of RA 11519, on 08 January 2021, the OCD CO issued OCD Memorandum No. 18, s. 2021 reiterating validity extension of the Republic Act (RA) No. 11494 or the “Bayanihan to Recover as One Act (Bayanihan 2)” likewise extending the validity of the Bayanihan 2 Funds until 30 June 2021;

**WHEREAS**, on 13 January 2021, the OCD RO-I received the approval letter of the requested fund for the maintenance and operating requirements of various isolation facilities in the Province of Ilocos Norte;

**WHEREAS**, the Purchase Request (PR) No. 2021-05-0076 of the Operations Section under the Disaster Risk Reduction and Management (DRRM) Division of OCD RO-I for the **Supply and Delivery of COVID-19 Reverse Transcription – Polymerase Chain Reaction (RT-PCR) Test Kit Supplies for the Province of Ilocos Norte** was submitted and approved on 07 May 2021 (**Annex A**);

**WHEREAS**, the Approved Budget for the Contract (ABC) was **Four Million Five Hundred Twenty-Two Thousand Five Hundred Pesos (Php 4,522,500.00)** charged against the RF - Bayanihan Act 2;



**WHEREAS**, on the same day of request, 07 May 2021, OCD RO-I Regional Director Eugene G. Cabrera, as Head of the Procuring Entity (HoPE), approved the Supplemental Project Procurement Management Plan (PPMP) (**Annex B**) and the Emergency Purchase Certificate (EPC) No. 2021-05-0013 (**Annex C**) recommending the adoption of **Alternative Method of Procurement** in accordance with **Negotiated Mode of Procurement - Section 53.2 for Emergency Cases** of the Revised Implementing Rules and Regulations (IRR) of RA 9184 for the implementation of the said project;

**WHEREAS**, the Government Procurement Policy Board (GPPB) Resolution No. 03-2020 dated 09 March 2020 provides that **Alternative Method of Procurement** in accordance with **Negotiated Mode of Procurement under Section 53.2 for Emergency Cases** of the Revised IRR of RA 9184 can be undertaken for *“instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation”*;

**WHEREAS**, GPPB Resolution No. 03-2020 dated 09 March 2020 authorized the End-User aside from the BAC to recommend to the HoPE or his duly authorized representative the immediate award of contract to the supplier known to have the legal, technical and financial capability;

**WHEREAS**, the OCD RO-I issued the Request for Quotation (RFQ) No. 2021-05-0061 on 07 May 2021 (**Annex D**);

**WHEREAS**, the Operations Section as implementing section, with the extended validity of Bayanihan 2, initiated the identification and negotiation with the prospective supplier namely, **SURGICO PHILS., INC.**, which complied with the technical and financial specifications of the project;


**WHEREAS**, the Operations Section further recommended **SURGICO PHILS., INC.** as the legally, technically and financially capable supplier for procurement of the said project;

**NOW, THEREFORE, WE**, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, indorse the recommendation of the implementing section, hereby **RECOMMEND** to the HoPE, the immediate award of contract to **SURGICO PHILS., INC.** for the **Supply and Delivery of COVID-19 Reverse Transcription – Polymerase Chain Reaction (RT-PCR) Test Kit Supplies for the Province of Ilocos Norte** in the amount **Four Million Two Hundred Thirty-Seven Thousand Five Hundred Pesos (Php 4,237,500.00) only**;
