**“RECOMMENDING THE AWARD OF CONTRACT TO MARKENZEL TRADING
FOR THE SUPPLY AND DELIVERY OF SLEEPING KITS FOR THE COVID-19
FACILITIES IN REGION 1”**

WHEREAS, on 11 September 2020, President Rodrigo Roa Duterte signed Republic Act (RA) No. 11494 or the “Bayanihan to Recover as One Act (Bayanihan 2)” in view of the continuous health emergency operation against the spread of the Coronavirus – 2019 (COVID-19);

WHEREAS, on 20 September 2020, the OCD RO-I submitted to the OCD Central Office (CO) the COVID-19 Facilities Maintenance and Operational Requirements in line with the Bayanihan Act 2;

WHEREAS, on 14 October 2020, the OCD CO approved the request for the operational and maintenance requirement of nine (9) isolation/treatment facilities identified in Region 1;

WHEREAS, on 29 October 2020, the OCD CO transferred to OCD RO-I a total of Thirty-Seven Million Seventy Thousand Pesos (Php 37,070,000.00) from the Regular Fund (RF) of the Bayanihan Act 2;

WHEREAS, on 09 November 2020, the OCD RO-I submitted fund modification request of the amount transferred to OCD CO;

WHEREAS, on 11 November 2020, the OCD CO approved the said modification request;

WHEREAS, the Purchase Request (PR) No. 2020-12-131 of the Disaster Risk Reduction and Management (DRRM) Division of OCD RO-I for the **Supply and Delivery of Sleeping Kits for the COVID-19 Facilities in Region 1** was submitted and approved on 17 December 2020 (**Annex A**);

WHEREAS, the Approved Budget for the Contract (ABC) was **Six Hundred Thirty Thousand Pesos (Php 630,000.00)** charged against the RF - Bayanihan Act 2;

WHEREAS, on the same day, OCD RO-I Regional Director Eugene G. Cabrera, as Head of the Procuring Entity (HoPE) approved the Supplemental PPMP and the Emergency Purchase Certificate (EPC) No. 2020-12-021 recommending the adoption of **Alternative Method of Procurement** in accordance with **Negotiated Mode of Procurement - Section 53.2 for Emergency Cases** of the Revised (IRR) of RA 9184 for the implementation of the said project (**Annex B**);

WHEREAS, on 17 December 2020, the DRRM Division of OCD RO-I, as the implementing unit, submitted a Supplemental Project Procurement Management Plan (PPMP) for the project **Supply and Delivery of Sleeping Kits for the COVID-19 Facilities in Region 1 (Annex C)**;

WHEREAS, the Government Procurement Policy Board (GPPB) Resolution No. 03-2020 dated 09 March 2020 provides that **Alternative Method of Procurement** in accordance with **Negotiated Mode of Procurement** under **Section 53.2 for Emergency Cases** of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 can be undertaken for "*instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation*";


WHEREAS, the OCD RO-I issued the Request for Quotation (RFQ) No. 2020-12-124 on 18 December 2020 (**Annex D**);

WHEREAS, the implementing office had identified and negotiated with a prospective supplier namely, **MARKENZEL TRADING**, that complied with the technical and financial specifications of the project;

WHEREAS, GPPB Resolution No. 03-2020 dated 09 March 2020 authorized the End-User aside from the BAC to recommend to the HoPE or his duly authorized representative the immediate award of the contract to the supplier known to have the legal, technical and financial capability;

WHEREAS, the DRRM Division further recommended **MARKENZEL TRADING** as the legally, technically and financially capable supplier for procurement of the said project;


NOW, THEREFORE, WE, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, indorse the recommendation of the implementing office, hereby **RECOMMEND** to the HoPE, the immediate award of contract to **MARKENZEL TRADING** for the **Supply and Delivery of Sleeping Kits**



for the COVID-19 Facilities in Region 1 in the amount **Six Hundred Thirty Thousand Pesos (Php 630,000.00)** only;


