WHEREAS, the BAC received a Purchase Request from Administrative and Financial Management Section (Annex A) for the project “Medical supplies for use during disinfection and COVID-19 proofing of personnel workstations at OCD VI and RDRRMC VI EOC whose funding source is from OCD DRRM 2021 (Annex B);
