**“RECOMMENDING THE AWARD OF CONTRACT TO DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE VEHICLE RENTAL FOR RP-VET FIELD VALIDATION ON NIA DAMAGED INFRA PROJECTS, REQUESTING FOR NDRRMF FOR DAVAO DEL NORTE & DAVAO ORIENTAL LGUS”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Vehicle Rental for RP-VET Field Validation on NIA damaged infra projects, requesting for NDRRMF for Davao del Norte & Davao Oriental LGUs was approved on February 22, 2021 with an Approved Budget for the Contract (ABC) of **Sixteen Thousand Five Hundred Pesos (Php 16,500.00)** which is included in the approved **OCDRO-XI DRRM FUND 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on February 22, 2021;

**WHEREAS**, three (3) prospective bidders, namely; Davao Tourist Transport Service Cooperative, Punisher Van Rental Association Inc. and DCND Transport Service submitted their respective quotations and documents thereof prior to the opening of bids on February 26, 2021;

**WHEREAS**, opening of quotation was held on February 26, 2021 wherein three (3) proponents submitted their respective quotations as follows:
