**“RECOMMENDING THE AWARD OF CONTRACT TO MMJS PHARMACY AND MEDICAL SUPPLIES THROUGH ALTERNATIVE MODE OF PROCUREMENT UNDER SECTION 53.2 (EMERGENCY PROCUREMENT) FOR THE PROVISION OF PERSONAL PROTECTIVE EQUIPMENT (PPES) FOR THE MANAGEMENT MAINTENANCE OF THE ISOLATION FACILITIES IN CARMEN, DAVAO DEL NORTE”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Provision of Personal Protective Equipment (PPEs) for the management maintenance of the Isolation Facilities in Carmen, Davao del Norte was approved on January 10, 2021 with an Approved Budget for the Contract (ABC) of **Five Hundred Sixty Thousand Eighty Pesos (Php 560,080.00)** which is included in the approved **BAYANIHAN 2 FUNDS 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on February 19, 2021;

**WHEREAS**, four (4) prospective bidders, namely; MMJS Pharmacy and Medical Supplies, NDMS Enterprise Inc., Karvin Pharma and YourMed Marketing submitted their respective quotations and documents thereof prior to the opening of bids on March 5, 2021;

**WHEREAS**, opening of quotation was held on March 5, 2021 wherein four (4) proponents submitted their respective quotations as follows:

- b. The issuance of a Notice of Award (NOA) in favor of **MMJS PHARMACY AND MEDICAL SUPPLIES**, in the amount of Five Hundred Forty Two Thousand Four Hundred Eighteen Pesos Only (**Php 542,418.00**) only;
