**“RECOMMENDING THE AWARD OF CONTRACT TO CARMEN GOVERNMENT OFFICIALS AND EMPLOYEES MULTI-PURPOSE COOPERATIVE THROUGH ALTERNATIVE MODE OF PROCUREMENT UNDER SECTION 53.2 (EMERGENCY PROCUREMENT) FOR THE PROVISION OF CATERING SERVICES FOR THE MANAGEMENT MAINTENANCE OF THE ISOLATION FACILITIES IN CARMEN, DAVAO DEL NORTE”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Provision of Catering Services for the management maintenance of the Isolation Facilities in Carmen, Davao del Norte was approved on January 10, 2021 with an Approved Budget for the Contract (ABC) of **Nine Hundred Eighty Thousand Pesos (Php 980,000.00)** which is included in the approved **BAYANIHAN 2 FUNDS 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on February 19, 2021;

**WHEREAS**, three (3) prospective bidders, namely; Carmen Government Officials and Employees Multipurpose Cooperative, Marka Kusinera and PF Lechonan and Eatery submitted their respective quotations and documents thereof prior to the opening of bids on March 5, 2021;

**WHEREAS**, opening of quotation was held on March 5, 2021 wherein three (3) proponents submitted their respective quotations as follows:

**WHEREAS**, Carmen Government Officials and Employees Multipurpose Cooperative, has been evaluated as the **Single Calculated Bid** for the project in the amount of Nine Hundred Fifty Thousand Four Hundred Pesos (**Php 950,400.00**) only;

**WHEREAS**, the post qualification of the aforesaid bidder was conducted on March 9, 2021, 11:00am at the Carmen Government Officials and Employees Multi-Purpose Cooperative, Municipal Ave., Purok 7, Ising, Carmen, Davao del Norte;

**WHEREAS**, Section 12 of RA 9184 mandates that the Office of Civil Defense Bids and Awards Committee (OCD-BAC) shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative;


**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the OCD-BAC, hereby **RECOMMEND** to the Head of the Procuring Entity (HoPE), the following:

- a. To declare **CARMEN GOVERNMENT OFFICIALS AND EMPLOYEES MULTI-PURPOSE COOPERATIVE**, as the **Single Calculated Responsive Bidder** for the Provision of Catering Services for the management maintenance of the Isolation Facilities in Carmen, Davao del Norte;
- b. The issuance of a Notice of Award (NOA) in favor of **CARMEN GOVERNMENT OFFICIALS AND EMPLOYEES MULTI-PURPOSE COOPERATIVE**, in the amount of Nine Hundred Fifty Thousand Four Hundred Pesos (**Php 950,400.00**) only;


