**“RECOMMENDING THE AWARD OF CONTRACT TO STARBRIGHT OFFICE DEPOT INC. THROUGH ALTERNATIVE MODE OF PROCUREMENT UNDER SECTION 53.2 (EMERGENCY PROCUREMENT) FOR THE PROVISION OF JANITORIAL SUPPLIES FOR THE MANAGEMENT MAINTENANCE OF THE ISOLATION FACILITIES IN CARMEN, DAVAO DEL NORTE”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Provision of Janitorial Supplies for the management maintenance of the Isolation Facilities in Carmen, Davao del Norte was approved on January 10, 2021 with an Approved Budget for the Contract (ABC) of **Five Hundred Forty Four Thousand Eight Hundred Sixty Five Pesos (Php 544,865.00)** which is included in the approved **BAYANIHAN 2 FUNDS 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on February 19, 2021;

**WHEREAS**, three (3) prospective bidders, namely; Prince Educational Supply, PrintComp Marketing and Starbright Office Depot Inc. submitted their respective quotations and documents thereof prior to the opening of bids on March 5, 2021;

**WHEREAS**, opening of quotation was held on March 5, 2021 wherein three (3) proponents submitted their respective quotations as follows:
