"RECOMMENDING THE AWARD OF CONTRACT TO DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE VEHICLE TO BE USED FOR THE RPMET FIELD MONITORING ON MARCH 17-19, 2021 IN THE LGUS OF DAVAO DEL SUR"

WHEREAS, the Purchase Request of the Regional Office-XI for the Vehicle to be used for the RPMET field monitoring on March 17-19, 2021 in the LGUs of Davao del Sur was approved on March 10, 2021 with an Approved Budget for the Contract (ABC) of **Thirty Six Thousand Pesos (Php 36,000.00)** which is included in the approved **OCDRO-XI DRRM FUND 2021**;

WHEREAS, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on March 12, 2021;

WHEREAS, four (4) prospective bidders, namely; Davao Tourist Transport Service Cooperative, Punisher Van Rental Association Inc., DCND Transport Service and Jaysam Car Rental submitted their respective quotations and documents thereof prior to the opening of bids on March 16, 2021;

WHEREAS, opening of quotation was held on March 16, 2021 wherein four (4) proponents submitted their respective quotations as follows:

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the OCD-BAC, hereby RECOMMEND to the Head of the Procuring Entity (HoPE), the following:

- a. To declare **DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE** as the **Single Calculated Responsive Bidder** for the Vehicle to be used for the RPMET field monitoring on March 17-19, 2021 in the LGUs of Davao del Sur;
- b. The issuance of a Notice of Award (NOA) in favor of **DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE** in the amount of Thirty Six Thousand Pesos (**Php 36,000.00**) only;


