**WHEREAS**, the Purchase Request of the Regional Office-XI for the Provision of Van Rental for Gawad Kalasag Seal (Mandatory Assessment to LDRRMC/Os) Field Validation on May 4-7, 17-19, 25-28, June 8-11, 15-20, 2021 in all Municipalities in Davao Region was approved on April 19, 2021 with an Approved Budget for the Contract (ABC) of **Two Hundred Thousand Pesos (Php 200,000.00)** which is included in the approved **OCDRO-XI DRRM FUND 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website and Philgeps Website on April 19, 2021;

**WHEREAS**, four (4) prospective bidders, namely; Davao Tourist Transport Service Cooperative, A-Five Car Rental & Punisher Van Rental Association Inc., & DCND Transport Service submitted their respective quotations and documents thereof prior to the opening of bids on April 23, 2021;
